Wedding Photography Contract

Agreement. This constitutes an agreement for photography services. It is understood that all proofs, digital files, and sample prints remain the property of the photographers and may be used for advertising, display or any purpose thought proper by the photographer. It also constitutes a formal Model Release for anyone personally involved in the wedding.

Reservation Fee. Upon signature, the photographer reserves the time and date agreed upon, and will not make other reservations for that time and date. For this reason all reservation fees are non-refundable unless a comparable engagement can be booked for the same date.

Liability. The photographers will not be held liable in the event of fire, casualty, act of God, or other cause beyond the control of the parties, or due to Photographer illness, in which case the Photographer shall return the deposit to the Client but, shall have no further liability with respect to the Agreement. Although all reasonable care will be taken with the equipment and photographs taken at the wedding, the photographers limit any liability for loss, damage or failure to deliver pictures for any reason to return of all photographers fees paid. Albums, prints, and all other products or materials may be shipped to the Client at the client's expense by a shipping method that allows tracking of the package and with an appropriate amount of insurance.

Substitute Photographer. The Photographer may substitute another photographer to take photographs in the event of Photographer's illness or of scheduling conflicts. In the event of such substitution, Photographer warrants that the photographer taking photographs shall be a competent professional.

Damage to Equipment. In the event any of the Photographer's equipment is damaged or destroyed, either accidentally or intentionally, by the Client, wedding guests and attendants, or employees of the Client, the Client is fully responsible for the equipment's replacement at current new market prices.

Miscellany. This Agreement incorporates the entire understanding of the parties. Any modifications of this Agreement must be in writing and signed by both parties. Any waiver of a breach or default hereunder shall not be deemed a waiver of a subsequent breach or default of either the same provision or any other provision of this Agreement.

Additional Portraits or services not included in the above package price will be billed at the prices stated in the photographer's price list. Additional photography time not included in the package description will be billed at \$75 per half hour / photographer.

Reservation Fee. A non-refundable reservation fee of \$250 is due at signing of this contract, and the balance must be paid at least one week prior to the date of wedding, and may be paid in prior installments if desired.
